Introducing Digarbon:

Decarbonisation Fund for Tertiary Education in Wales

- £20 million of loan funding
- Targeting the tertiary education sector in Wales
- Objectives:
 - To support implementation of **heat decarbonisation, energy efficiency, renewable energy, and EV & EV charging infrastructure** measures.
 - Funding for the scheme has been provided by Welsh Government to help the **public sector** meet its **ambition** to be **net zero by 2030**.

Cyflwyno Digarbon:

Cronfa Ddatgarboneiddio Addysg Uwch yng Nghymru

- £20 miliwn o gyllid benthyciadau
- Targedu'r sector addysg drydyddol yng Nghymru
- Amcanion:
 - Cefnogi gweithredu mesurau **datgarboneiddio gwres, effeithlonrwydd ynni, ynni adnewyddadwy, a cherbydau trydan a'u seilwaith gwefru.**
 - Llywodraeth Cymru sy'n darparu'r cyllid ar gyfer y cynllun i helpu'r **sector cyhoeddus** gyrraedd ei **uchelgais** i fod yn **sero net erbyn 2030**.



Interest rates

- Change in HM Treasury rules
- Rate will be based on the government borrowing rate
- Currently set at 2.05% APR
- A fixed rate will be applied for the duration of the loan

- Bydd y gyfradd yn seiliedig ar gyfradd fenthyca y llywodraeth
- Wedi'i gosod ar 2.05% APR ar hyn o bryd
- Defnyddir cyfradd sefydlog trwy gydol cyfnod y benthyciad



Salix funding schemes

Wales Funding Programme

- Running SEELS since 2006
- Carbon cost threshold: £350 tCO₂e
- Payback: 10 years

Digarbon

- New fund
- No carbon cost threshold
- No technical payback requirement
- Possibility of using the Wales Funding Programme to combine funding



- Organisations
 - Buildings
- Technologies
 - Costs

- Sefydliadau
- Adeiladau
- Technolegau
- Costau

Organisations

- Higher and further education institutions
- Must be a public sector body as defined in the Public Contracts Regulations 2015
- Registered in Wales

Buildings

- Existing non-domestic buildings
- Owned or with long-term lease with at least 10 years remaining
- Savings must be passed to the eligible public body applying for the loan

Sefydliadau

- Sefydliadau addysg uwch ac addysg bellach
- Rhaid bod yn gorff sector cyhoeddus yn unol â'r diffiniad yn Rheoliadau Contractau Cyhoeddus 2015
- Wedi'i gofrestru yng Nghymru

Adeiladau

- Adeiladau annomestig sydd eisoes yn bodoli
- Yn berchen neu prydles hirdymor gydag o leiaf 10 mlynedd ar ôl
- Rhaid pasio'r arbedion i'r corff sector cyhoeddus sy'n ymgeisio am y benthyciad

Technologies

- Low carbon heating system, heat distribution systems, building fabric upgrades* (must include)
- Energy efficiency measures
- Renewable energy
- Electric vehicles and charging infrastructure

Costs

- Design, procurement, purchase of equipment & materials, build, install, commissioning
- Project management (capitalised)

Technolegau

- System wresogi carbon isel, systemau dosbarthu gwres, gwella ffabrig adeiladau* (rhaid cynnwys)
- Mesurau effeithlonrwydd ynni
- Ynni adnewyddadwy
- Cerbydau trydan a'u seilwaith gwefru

Costau

- Dylunio, caffael, prynnu offer a deunyddiau, adeiladu, gosod, comisiynu
- Rheoli prosiect (wedi'i gyfalafu)

Project payback

- No technical payback calculation based on financial savings
- Repayment plan will be agreed between applicant and Salix
- Loan must be repaid in full, including interest, by 31 October 2048

- Carbon cost metric
 - Project payback

Carbon cost metric

- Automatically calculated in the application form support tool
- No threshold for project eligibility
- £550 tCO₂e is the maximum carbon cost deemed effective value for money. Where exceeded, applications must provide reasoning

Metrig cost carbon

Whole building & fabric first approach

‘Whole building’

- Comprising energy conservation measures and others which reduce the heat or electrical demand

‘Fabric first’

- Improving thermal performance by prioritising improvements to the building fabric to the level appropriate for buildings listed in the application form

‘Adeilad cyfan’

- Yn cynnwys mesurau gwarchod ynni ac eraill sy’n lleihau’r galw am wres neu drydan

‘Ffabrig yn gyntaf’

- Gwella perfformiad thermol drwy flaenoriaethu gwelliannau i ffabrig yr adeilad i lefel sy’n briodol ar gyfer yr adeiladau a restrir yn y ffurflen gais



Weighted criteria

Meini prawf wedi'u pwysoli

Strategic Assessment (Aseiad Strategol)	15%
Technical Feasibility (Dichonoldeb Technegol)	30%
Financial Costs (Costau Ariannol)	20%
Project Delivery (Cyflawniad y prosiect)	20%
Social Contribution (Cyfraniad Cymdeithasol)	15%



Social contribution

Based on Well-being of Future Generations (Wales) Act and the Future Generations Framework for projects

Four sections:

- Low-carbon economy
- Community involvement and empowerment
- Promoting environmental and public health
- Welsh heritage and global citizenship

Dual-scheme funding

Wales Funding Programme

£350/tCO₂e, 10 year payback

Purpose

Maximise the spread of Digarbon funding

LED lighting portion may be funded through WFP to enable Digarbon to fund more low carbon heat

Deliverability calls

After a successful technical assessment, we will contact you to arrange a deliverability call.

This will include discussions covering:

- Project delivery (project programme, procurement, approvals etc.)
- Potential dual-scheme funding element and implications
- Requirements of loan (monitoring and repayments)
- Opportunity to ask us questions

How to apply

- The application form will be available in June 2024
- Application window opens in July and closes in August
- Applications will be made through the application portal on the Salix website
- Applications must be made by an individual from the eligible organisation. Applications made by external parties will be rejected

Interest rate & repayment

- 2.05% fixed rate
- Interest and capital repayment made together, annually
- Interest repayments begins in the first financial year from loan drawdown
- Capital repayments begins after project completion
 - Value to be determined by applicant
- Loan must be repaid entirely by October 2048
